Youth Legal Service will have the membership classes and limits on the number of Members as set out below:

## 4. Associate Members.

Membership of Youth Legal Service may at any one time include an unlimited number of Associate Members, each such Member being a person:

who is not eligible for membership as a Social Service Organisation Member; and who is not a natural person.

A person may only hold a single class of membership at any one time.

Any two Members may nominate a person to be a Member.

Staff employed by the Association are not entitled to be Members while so employed.
